Excerpted from the Criminal Records Review Act
RELEVANT OFFENCES

Sexual Interference; Invitation to Sexual touching; Sexual Exploitation; Incest; Anal Intercourse; Bestiality; Child Pornography; Parent or Guardian Procuring Sexual Activity; Householder Permitting Sexual Activity; Corrupting Children; Indecent Acts; Exposure; Trespassing at Night; Vagrancy; Procuring a Person for the Purposes of Prostitution; Living off Avails of Child Prostitution; Attempting to Obtain the Sexual Services of a Child; Abandoning Child; Causing Death by Criminal Negligence; Causing Bodily Harm by Criminal Negligence; Murder; Punishment for Murder; Punishment for Manslaughter; Punishment for Infanticide; Killing Unborn Child in Act of Birth; Attempt to Commit Murder; Accessory after Fact to Murder; Neglect to Obtain Assistance in Child Birth; Concealing Body of Child; Causing Bodily Harm with Intent; Administering Noxious Thing; Overcoming Resistance to Commission of Offence; Criminal Harassment; Uttering Threats; Assault; Assault with a Weapon of Causing Bodily Harm; (Aggravated Assault); Unlawfully Causing Bodily Harm; Sexual Assault; Sexual Assault with a Weapon; Threats to a Third Party or Causing Bodily Harm; Aggravated Sexual Assault; Removal of a Child from Canada; Kidnapping/Forcible Confinement; Hostage Taking; Abduction of Person under Sixteen; Abduction of Person under Fourteen; Abduction in Contravention of Custody Order; Abduction; False Messages/Indecent Telephone Calls/Harassing Telephone Calls; Where Injury or Damage Feared; Where Fear of Sexual Offence.
